Performing construction works on the rehabilitation and adaptation of the building of the Embassy of the Republic of Serbia in Ankara, with a "turn key" clause No. 3/2018

The estimated value of the procurement of works is 12,000,000.00 dinars excluding VAT, that is, 14,400,000 dinars with VAT, which amounts to 100,938.47 euros without VAT, or 121,126.17 euros with VAT.
